Requirements / Guidelines:

1. Must be an active member of Indiana Extension Homemakers Association
2. Exchange will travel to destination by means of transport assigned.
3. No one will be allowed to meet up with or travel along with exchange while on official visit to host country.
4. Exchange will stay with host families in country visiting
5. Travel expenses will consist of Airfare to exchange country and back, paid for by State Indiana Exchange Homemakers Association.
6. Accommodations, transportation and meals, while abroad, will be funded by host country.
7. Personal purchases will be at the expense of the exchange
8. Exchange should have qualities and attributes to accept the standards of others.
9. Exchange should realize this is a work program and **NOT** a vacation
10. Must hold a current passport and arrange for a visa if necessary
11. Former exchange representatives may not apply
12. Exchange must carry adequate insurance for duration of trip. (exchange's expense)

Guidelines for Presentations in Indiana

1. Will be available to do 40 presentation within the state of Indiana to IEHA membership
2. Will do a presentation at Home and Family Conference
3. Will be reimbursed for mileage to and from presentations for IEHA membership by line item on IEHA state budget
4. Presentation coordinator from Exchange Homemaker committee will schedule exchange's presentation with agreement from exchange
5. Exchange will prepare a power point presentation to be used while on location speaking.
